

Power Purchase Agreements (PPAs) Hunter & New England Renewable Energy Zone

July 2024

EnergyCo is delivering the Hunter & New England Renewable Energy Zone (REZ) to provide a clean, affordable and reliable power supply for energy consumers across NSW. The REZ will initially unlock three gigawatts of new transmission capacity for solar, wind and storage projects within the next decade.

Power Purchasing Agreements (PPAs)

EnergyCo is working with industry to provide positive economic outcomes for communities in the Hunter & New England REZ. We are partnering with Business Renewables Centre Australia (BRC-A), Australia's peak Corporate PPA training and education organisation, to support the uptake of PPAs in the REZ.

PPAs allow businesses and councils to partner with renewable energy generations projects, such as solar or wind farms, to purchase electricity for an agreed price and term. In this way, PPAs enable local businesses and councils to invest and share in the benefits of renewable energy generation.

They are a contractual agreement between renewable energy generation projects and buyers such as businesses and councils. They are typically signed for a long-term period between 5 to 10+ years.

- deliver benefits such as local employment, investment in infrastructure and biodiversity rehabilitation.

• support local economic development.

For local and regional business, PPAs offer:

- an opportunity to achieve their renewable energy targets and reduce their carbon footprint.
- a demonstration of sustainability commitments to employees, customers and governments.
- improve budget certainty and reduce price risk.
- an opportunity to invest in local renewable energy projects.
